



**SCHEDULING ORDER REGARDING REHABILITATOR'S MOTION

This matter came before the Court on the Rehabilitator's motion (the "Motion") to enforce this Court's March 24, 2010 Order for Temporary Injunctive Relief against Assured Guaranty Corp. and Assured Guaranty Re Ltd. (collectively "Assured"), which was filed on April 15, 2011. On April 20, 2011, Ambac Assurance Corporation ("AAC") joined the Motion.


In connection with the Assured Motion, the Court hereby orders the following schedule:

1. All briefs, affidavits or other submissions in opposition to the Motion by Assured or any other party with an interest in the Motion shall be filed and served on or before Monday, May 9, 2011.
2. Reply briefs, if any, shall be filed by the Rehabilitator and AAC on or before May 16, 2011.
3. All written submissions shall be filed with the Clerk for the Dane County Circuit Court, with courtesy copies provided to Judge Johnston at the Lafayette County Courthouse (via mail or hand delivery). Service on other parties shall be effected electronically consistent with the past practice in this proceeding.

4. A hearing on the Motion shall be held on May 25, 2011 starting at 9:00 a.m. (CDT) at the Lafayette County Courthouse. The hearing shall be open to the public.
